# Task 1.3 Guiding Principles

# **Purpose**

During *Task 1.2 Coop Detectives*, you learned how a cooperative is different from other types of businesses. All cooperatives follow seven guiding principles established by the Rochdale Pioneers, the first modern cooperative, in 1844. These principles guide cooperative operations and make the organizations unique to other types of business structures. How are these principles incorporated in a business?

- 4. Record the International Cooperative Alliance (ICA) description of each principle in Table 1.
- 5. Discuss with your class how your meaning was different or similar to the ICA description. Your teacher will lead the discussion.
